Invitation for Bids

Sealed bids are invited for procurement of Bulk Medicines / Vaccines, X- Rays films, Surgical Disposables, Sutures, Dental Material, Dressing Material, Dialysis Material and Lab Chemicals/ Kits etc during the financial year 2017-18, which will be received up to 22.06.2017 at 1200 hrs. in the office chamber of the Secretary Health, GoAJK Block No. 10, New Secretariat, Chattar, Muzaffarabad and will be opened on the same day at 1230 hrs. in the presence of Bidders or their Authorized representatives who choose to attend the meeting of bid opening.

1. Bidding shall be conducted through Single Stage - Two Envelopes bidding procedure of AJK Public Procurement Rules, 2017. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters. Financial Proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.
2. For supply of Pharmaceuticals /Vaccines, X- Rays films, Surgical Disposables, Sutures, Dental Materials, Dressing Materials and Lab Chemicals/ Kits/ Dialysis Material etc. all Manufactures/ Authorized Importers and authorized distributors can participate.
3. Bid Security (CDR) @ 2% of total bid value in the name of Director General Health AJK Muzaffarabad must be accompanied with the bid. Cheques shall not be accepted.
4. Bids shall remain valid upto 30-06-2018.
5. A complete set of Bidding document including detail specifications, Quantity, terms & Conditions can be obtained upto 21.06.2017 on submission of written application and upon Payment of Rs. 3000/- (Rupees Three thousand) (Non refundable) in shape of Bank Draft as bidding document fee from the office of the Director General Health AJK New District Headquarter Complex Room No.31, 1st Floor, Block "F" Muzaffarabad.
6. All taxes / duties levied by GoAJK will be chargeable from the bills under admissible rules.
7. All bids should be submitted in Tape Binding. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents/form is mandatory.
